# **Personal Information Protection Form**

Within the current (or in the future, as the case may be) scope of business permitted by law, it is necessary to collect, process, use, and/or transmit internationally within the necessary scope of business operation subject to the business classifications it belongs to between you and Tigerair. Tigerair Taiwan Co. Ltd. (hereinafter "Tigerair") shall notify you the following in accordance with Personal Information Protection Act of Republic of China (the "Act") and the relevant regulations. Please read as follows:

#### Classification of Collection :

On the basis of the specific purposes, collect personal information includes name, ID card (or, passport number), gender, date of birth, communication ways, and others such as applications regarding business, reservation. All the personal information will be subject to the information collected from the relevant business between Tigerair and the clients, the clients, or third parties such as travel agents.

### 2. Purpose of Collection:

067 Credit card, cash card, debit card or electronic value-stored card business; 181 Other business operation in accordance with the business registration project or organization Prospectus.

3. Period, Area, Target, and Way of the Use of Personal Information:

#### A. Period

Within time period of specific purpose, in accordance with relevant laws/regulations or agreements, or necessity of business operation.

#### B. Area

Republic of China, locations of flight destination, the airports of flight destination, locations where receivers reside through international transmission not restricted by the governmental authority in charge of subject industry, locations where the appointed institutions reside, and locations of business of institutions Tigerair collaborates with.

#### C. Target

Tigerair, its branches, its affiliates, travel agents, Civil Aeronautics Administration, National Immigration Agency, Aviation Police Bureau, insurance companies Tigerair deals with, or companies the insurance companies deal with regarding re-insurance business, other appointed institutions, receivers of international transmission not restricted by the governmental authority in charge of subject industry, companies Tigerair collaborates with respect to promotion, other institutions Tigerair deals with, and investigation agencies or authorities in accordance with laws.

## D. Way

The Internet, electronic mail, phone contact, written mail, and fax, and so on.

- 4. In accordance with Article 3 of the Act, the Party may exercise the following right with regard to the personal information:
- A. Inquire, request for a review, or request for making duplications of the personal information, and Tigerair may charge a fee for it.
- B. Request for supplement or correction of the personal information if there is any variation, to keep it correct, latest, and complete.
- C. Request for discontinue collection, processing, use, or deletion of the personal information; however,



Tigerair may decline such request if it is necessary for Tigerair to operate business.

5. The Impact of Not Provide the Personal Information:

You may freely decide whether to provide the personal information; however, Tigerair will not be able to conduct the necessary review and handling process so not to provide clients the relevant services.

6. Governing Law & Jurisdiction

The interpretation, application of this form, and any dispute relating to this form, shall be in accordance with laws of Republic of China, and be submitted to Taiwan Taipei District Court for the first instance.
